#### 1. Purpose

The aim of this Use of Electronic Devices Policy is to provide guidance to pupils and their families regarding the possession and use of personal electronic devices on school property.

### 2. Scope

This Use of Electronic Devices Policy applies to all pupils of Scoil Mhuire CBS as they participate in school activities, including those which take place off the school premises.

### 3. Principles

For a variety of reasons, families may deem it necessary that a pupil have an electronic device on their person as they travel to and from school. Therefore, families may apply to the school requesting permission for a pupil to bring a personal electronic device to school. In order to do so, the relevant Application Form (included as an Appendix to this policy) should be completed and its contents discussed in the home. This form should be submitted to the relevant Class Teacher, and will then be processed by school authorities. Approval automatically expires on June 30<sup>th</sup> each year, and a new application must be made each September.

## 4. Policy

Pupils' personal electronic devices may only be brought to school when approval to do so has been granted by school authorities. No pupil is permitted to bring a personal electronic device – including mobile phones and smartwatches capable of making or receiving calls and texts – to school without prior permission.

Certain conditions apply for permission to bring a mobile phone or smartwatch to school. These conditions include:

- Acknowledgement that whilst the school will take reasonable care in relation to the
  electronic device, any loss or damage sustained to the device will not be the
  responsibility of the school.
- The pupil's electronic device is properly labelled.
- Mobile phones must be turned off prior to entering the school premises and handed to the Class Teacher on entering the classroom.
- Smartwatches must be turned on school mode (disabling calls and texts) prior to entering the school premises and handed to the Class Teacher on entering the classroom.
- It is the responsibility of the pupil themselves to ensure that they collect their electronic device at dismissal time.
- The mobile phone or smartwatch can only be switched on when the pupil has left the school premises.

In taking reasonable care in relation to pupils' personal electronic devices, please note that there is a secure lockbox in each classroom. Devices handed to the Class Teacher will be stored here for the duration of the school day.

Any pupil who fails to comply with the school policy as outlined in this document will face sanctions in accordance with the school's Code of Behaviour. Any misuse of electronic devices deemed to be cyber bullying will be addressed under the school's Anti-Bullying Policy.

Where a pupil is in possession of a personal electronic device without permission, that device may be confiscated by a member of staff. Should a pupil's electronic device be confiscated, it will be retained securely in the school office and will only be returned to the family of the offending pupil on written request by an adult. The school will require a written guarantee from the parents of the offending pupil that no such occurrence will happen in future.
